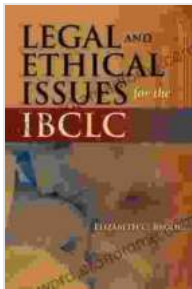

Informed Consent

Informed consent is a legal and ethical requirement that ensures that patients understand the risks and benefits of a procedure or treatment before they agree to it.

Scope of Practice

The scope of practice for IBCLCs is defined by the International Lactation Consultant Association (ILCA).

IBCLCs are qualified to provide the following services:

- Lactation counseling and education
- Breastfeeding management and support
- Breastfeeding assessment and diagnosis
- Lactation care plans
- Referrals to other healthcare professionals

IBCLCs are not qualified to provide medical diagnosis or treatment.

Cultural Competence

Cultural competence is the ability to provide care that is sensitive to the cultural beliefs and values of patients.

As an IBCLC, it is important to be aware of the cultural diversity of your patients.

You can provide culturally competent care by:

- Learning about the cultural beliefs and values of your patients
- Using interpreters when necessary

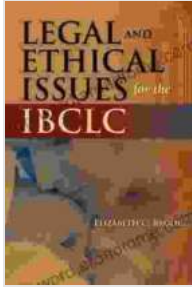

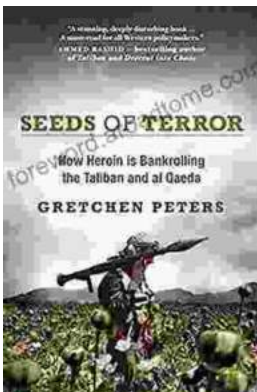
